- You/participating centers will keep the "© Boston Medical Center, Dr. Matthew Grossman, and Children's Hospital at Dartmouth-Hitchcock" header/footer on any ESC Care Tool materials individualized to ACT NOW clinical trial settings.
- If you/participating centers publish using the ESC Care Tool, you will credit Boston Medical Center, Yale, and CHaD as the ESC Care Tool's co-creators.
- You may grant sublicenses to NRN sites for purposes of conducting primary, secondary, and tertiary studies within the NRN.
- As the ESC Care Tool is still in its early investigative phase, to the extent collected, you will share any feedback received from participating centers with the ESC Care Tool development team following completion of the trial.
- Final manuscript copies of any work that is published from the ACT NOW trial using the ESC Care Tool will be shared with the ESC Care Tool development team.
